Residents of the Adult Home and Enriched Housing – Renken Apartments are encouraged to engage in visitation with their Family and Friends in such a way as to adhere to core principles of infection prevention and control.

The following **Check Out Appointment Process, Subject to further CDC / DOH updates:**

Contact the Adult Home Lobby *front desk receptionist* to SCHEDULE the date and time of the intended pick up of our Resident, for entry in our respective Scheduling Book for either the AH or the EHP Facility. Advise the receptionist of the intended date and time of return of our Resident.

EVERY Resident Family Member or Friend arriving at PHS for pick-up of our Resident, MUST CHECK-IN at the Adult Home Lobby reception desk and Sign Out the Resident for the Off-Site Visitation, AND, *upon return*, Sign back In the Resident at the same Adult Home Lobby front desk with the receptionist on duty.

Your compliance with our Contact Tracing obligations with the State DOH is of the utmost importance for the safety of our Residents, Staff, and other Visitors, not to mention satisfying our Regulatory Requirements.

BY SIGNING BELOW, the family member / friend Visitor acknowledges taking the above named Resident of PHS in their custody for the duration of the Off-Site Visit and accordingly undertakes to engage in common sense safety measures, including the follow the Covid-19 protocols:

Masks should always be worn At All Times, in addition to maintaining safe social distancing (at least 6 feet apart), especially for the Resident, when you come in contact with people who do not live with you or your immediate household.

Remind our Resident to :

- A. wash his or her hands often** with soap and water for at least 20 seconds especially after you have been blowing your nose, coughing, or sneezing. .
- B. Wear the mask** over your nose and mouth and secure it under your chin. Fit the mask snugly against your nose and mouth and secure it under your chin.
- C. Avoid poorly ventilate spaces** as much as possible. If indoors, bring in fresh air by opening windows and doors, if feasible.
- D. Avoid touching** your eyes, nose, and mouth with unwashed hands.

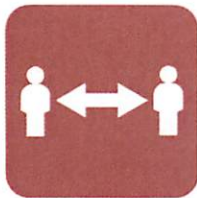
